PRIVACY POLICY OF NICKWARE GROUP

This Personal Data Privacy Policy (hereinafter referred to as the Privacy Policy) applies to all information, the site administration (hereinafter referred to as NickWare Group) can obtain through the site located on the domain name nickware.group , about the User while using the site, programs and products hosted on the domain name nickware.group .

1. DEFINITION OF TERMS

- 1.1. This Privacy Policy uses the following terms:
- 1.1.1. "Administration of the company's website (hereinafter referred to as the Website Administration)" is a person who organizes and (or) carries out the processing of personal data, and also determines the purposes of processing personal data, the composition of personal data to be processed, actions (operations) performed with personal data.
- 1.1.2. "Personal data" any information relating to a directly or indirectly identified or identifiable natural person (subject of personal data).
- 1.1.3. "Processing of personal data" any action (operation) or a set of actions (operations) performed with or without the use of automation tools with personal data, including collection, recording, systematization, accumulation, storage, clarification (updating, changing), extraction, use, transfer (distribution, provision, access), depersonalization, blocking, deletion, destruction of personal data.
- 1.1.4. "Confidentiality of personal data" is a mandatory requirement for the Operator or other person who has gained access to personal data to prevent their distribution without the consent of the subject of personal data or other legal grounds.
- 1.1.5. "User of the company's website (hereinafter referred to -as the User)" is a person who has access to the Website via the Internet and uses the Website and the company's online store.
- 1.1.6. A "cookie" is a small piece of data sent by a web server and stored on the user's computer, which the web client or web browser sends to the web server in an HTTP request each time it tries to open a page of the corresponding site.
- 1.1.7. "IP address" is a unique network address of a node in a computer network built using the IP protocol.

2. GENERAL PROVISIONS

2.1. The use by the User of the company means acceptance of this Privacy Policy and

the terms of processing of the User's personal data.

- 2.2. In case of disagreement with the terms of the Privacy Policy, the User must stop using the site.
- 2.3. This Privacy Policy applies only to the site located on the domain name nickware.group. The site administration does not control and is not responsible for third-party sites to which the User can follow the links available on the site.
- 2.4. The site administration does not verify the accuracy of personal data provided by the Site User.

3. SUBJECT OF THE PRIVACY POLICY

- 3.1. This Privacy Policy establishes the obligations of the Administration of the company's website to not disclose and ensure the privacy protection of personal data that the User provides at the request of the Website Administration when registering on the company's website or when placing an order for the purchase of the Goods.
- 3.2. Personal data authorized for processing under this Privacy Policy is provided by the User by filling out the registration form on the NickWare Website Group in the "Registration" section and include the following information:
- 3.2.1. surname, name, patronymic of the User;
- 3.2.2. display name (nickname) of the User;
- 3.2.3. contact phone number of the User;
- 3.2.4. e-mail address (e-mail);
- 3.2.5. Date of Birth;
- 3.2.6. information provided by technical support.
- 3.3. NickWare Group protects Data that is automatically transmitted when viewing ad units and when visiting pages on which the system's statistical script ("pixel") is installed:
- IP address;
- information from cookies :
- information about the browser (or other program that provides access to display ads);
- access time;

- address of the page on which the ad unit is located;
- referrer (address of the previous page).
- 3.3.1. Disabling cookies may result in the inability to access parts of the company's website that require authorization.
- 3.3.2. NickWare Group collects statistics about the IP addresses of site visitors. This information is used to identify and solve technical problems, to control the legality of financial payments.
- 3.4. Any other personal information not specified above (purchase history, browsers and operating systems used, etc.) is subject to secure storage and non-distribution, except as provided in paragraphs . 5.2. and 5.3. of this Privacy Policy.

4. PURPOSE OF COLLECTING USER'S PERSONAL INFORMATION

- 4.1. The User's personal data may be used by the Administration of the company's website for the following purposes:
- 4.1.1. Identification of the User registered on the NickWare website Group , to place an order through the online store.
- 4.1.2. Providing the User with access to personalized resources of the NickWare Site group .
- 4.1.3. Establishing feedback with the User, including sending notifications, requests regarding the use of the Company's Website, the company's products, the provision of services, processing requests and applications from the User.
- 4.1.4. Determining the location of the User to ensure security, prevent fraud.
- 4.1.5. Confirmation of the accuracy and completeness of personal data provided by the User.
- 4.1.6. Creating an account to use the company's products and make purchases if the User has agreed to create an account.
- 4.1.7. Notifying the User of the Company's Website about the status of the Order.
- 4.1.8. Processing and receiving payments, confirming tax or tax benefits, contesting a payment, determining the right to receive a credit line by the User.
- 4.1.9. Providing the User with effective customer and technical support in case of problems related to the use of the Company's Website.
- 4.1.10. Providing the User with his consent, product updates, special offers, pricing information, newsletters and other information on behalf of the company or on behalf of the company's partners.
- 4.1.11. Implementation of advertising activities with the consent of the User.

4.1.12. Providing the User with access to the websites or services of the company's partners in order to obtain products, updates and services.

5. METHODS AND TERMS OF PROCESSING PERSONAL INFORMATION

- 5.1. The processing of the User's personal data is carried out without time limit, in any legal way, including in personal data information systems using automation tools or without using such tools.
- 5.2. The User agrees that the Site Administration has the right to transfer personal data to third parties, in particular, courier services, postal organizations, telecommunication operators, solely for the purpose of fulfilling the User's order placed on the NickWare Site Group, including the delivery of the Goods.
- 5.3. The User's personal data may be transferred to the authorized state authorities of the Russian Federation only on the grounds and in the manner established by the legislation of the Russian Federation.
- 5.4. In case of loss or disclosure of personal data, the Site Administration informs the User about the loss or disclosure of personal data.
- 5.5. The site administration takes the necessary organizational and technical measures to protect the User's personal information from unauthorized or accidental access, destruction, modification, blocking, copying, distribution, as well as from other illegal actions of third parties.
- 5.6. The Site Administration, together with the User, takes all necessary measures to prevent losses or other negative consequences caused by the loss or disclosure of the User's personal data.

6. OBLIGATIONS OF THE PARTIES

6.1. The user is obliged:

- 6.1.1. Provide information about personal data necessary to use the Company's Website.
- 6.1.2. Update, supplement the provided information about personal data in case of changes in this information.

6.2. The site administration is obliged:

- 6.2.1. Use the information received solely for the purposes specified in clause 4 of this Privacy Policy.
- 6.2.2. Ensure that confidential information is kept secret, not disclosed without the prior written permission of the User, and also not to sell, exchange, publish, or disclose in other possible ways the transferred personal data of the User, with the exception of clauses . 5.2. and 5.3. of this Privacy Policy.
- 6.2.3. Take precautions to protect the confidentiality of the User's personal data in

accordance with the procedure usually used to protect this kind of information in existing business transactions.

6.2.4. Block personal data relating to the relevant User from the moment of the request or request of the User or his legal representative or authorized body for the protection of the rights of subjects of personal data for the period of verification, in case of revealing inaccurate personal data or illegal actions.

7. RESPONSIBILITIES OF THE PARTIES

- 7.1. The site administration, which has not fulfilled its obligations, is liable for losses incurred by the User in connection with the unlawful use of personal data, in accordance with the legislation of the Russian Federation, with the exception of cases provided for in paragraphs . 5.2., 5.3. and 7.2. of this Privacy Policy.
- 7.2. In case of loss or disclosure of Confidential Information, the Site Administration is not responsible if this confidential information:
- 7.2.1. Became public property before its loss or disclosure.
- 7.2.2. It was received from a third party until it was received by the Site Administration.
- 7.2.3. Was disclosed with the consent of the User.

8. DISPUTES RESOLUTION

- 8.1. Before going to court with a claim on disputes arising from the relationship between the Site User and the Site Administration, it is mandatory to submit a claim (a written proposal for a voluntary settlement of the dispute).
- 8.2. The recipient of the claim, within 30 calendar days from the date of receipt of the claim, notifies the claimant in writing of the results of the consideration of the claim.
- 8.3. If an agreement is not reached, the dispute will be referred to the judicial authority in accordance with the current legislation of the Russian Federation.
- 8.4. The current legislation of the Russian Federation applies to this Privacy Policy and the relationship between the User and the Site Administration.

9. ADDITIONAL TERMS

- 9.1. The site administration has the right to make changes to this Privacy Policy without the consent of the User.
- 9.2. The new Privacy Policy comes into force from the moment it is posted on the Company's Website, unless otherwise provided by the new version of the Privacy Policy.
- 9.3. All suggestions or questions regarding this Privacy Policy should be reported to the contact details specified in the "Contact Information" section.
